Community Updates from Zach Friend

2nd District County Supervisor



There has been a lot going on over the last few months. The lack of rain (while not good for our aquifers) has allowed for storm damage work on Valencia and on Soquel at the trestle as well as construction to continue work at Rancho del Mar and the Aptos Village. Rancho del Mar is being remodeled in phases and they anticipate that each phase will be under construction for 4-6 months. Aptos Village still anticipates having New Leaf and some other shops and restaurants open later this year (early Fall) with some of the housing open earlier. The major road improvements have been completed there (including the new traffic signals) with additional work starting soon on the new Parade Street (the middle of the Village).

Cannabis

The Board of Supervisors has been working on completing rules for the cultivation of cannabis. I have been focused on ensuring that commercial cultivation occurs in proper areas and not in residential districts or rural residential areas that would be most impacted. This has been a very extensive process — with changes to state law on cultivation and recreational use also adding complexities. The Planning Commission and Board of Supervisors will have additional hearings on this in March and April — if you are interested in this issue I encourage you to attend one of these upcoming meetings or submit your comments online in advance. You can always feel free to call me with any questions regarding what is being proposed.

Aptos Village Measure J Units

If you are renting in Rio del Mar (and are a first-time homebuyer) you might be interested in the new Aptos Village Measure J units that will be available for purchase. These are deed-restricted affordable homeownership units in the new Aptos Village project and they will be available for first-time home buyers with household earnings at or below 120 percent of the area median income. Ten total units will available (1,2, and 3-bedroom homes).

The estimated price of the Aptos Village Measure J homes is in the \$256,000 - \$280,000 range for a 1 -bedroom, \$296,000 - \$322,000 for a 2 -bedroom and \$338,000 - \$363,000 for a 3 -bedroom.

Applications are due May 18th and a drawing will be held on June 1st for qualified applicants. We expect a significant amount of interest in these units so to learn more about how to apply (and to confirm your eligibility), you can visit the Planning Department's website at www.sccoplanning.com (halfway down the page you will see a link for the Aptos Village units) or call 454-2336.

Seabreeze Tavern Lots

My office receives regular questions regarding the lots next to the Seabreeze Tavern. The county has purchased the lots as part of a tax auction and we cleaned them up (removing a significant number of loads of trash from the lots). We are looking at short term and long term uses for the lots — with a goal of possibly having the lots become a small public park in the longer term. Right now, there is no dedicated funding for that, so we are looking at shorter term uses (with shorter term being 5 years of maybe more) that would service the public better than a fenced-up lot! We've been told by many in Rio del Mar that it would be good to have something there where people can enjoy the outdoors and still enjoy a meal — a meeting place for the Esplanade area.

Our County Parks Department is working on an RFP process to see if there are local proprietors interested in that location and what they might be interested in using it for. The funding from leasing of the location would be used to make improvements to the County owned or maintained areas along the Esplanade and Beach Drive and help eventually fund the long-term plan for that space. Your continued feedback on this is appreciated. I think it was an important step to get the space into public ownership, so we could clean them up and help them become a positive public location moving forward.

County Parks Strategic Plan Update

Last spring, the Santa Cruz County Department of Parks, Open Space and Cultural Services initiated extensive community outreach for opinions and advice concerning the first County Park Strategic Plan. The Strategic Plan is intended to provide an overarching structure and timeline guidance for the Parks Department to maintain safe public use of 1,400-acres of county parkland including our own Seacliff Village County Park, and coastal pathways, and to prioritize current indoor and outdoor recreational and cultural programs throughout our family of 64 county parks.

For example, through last year's five county-wide community workshops and the on-line survey, Aptos residents revealed they would like to have more neighborhood parks and to stop having to travel to playgrounds in other parts of the County. Additionally, Aptosians would like an expansion in the variety of recreational uses at existing parks and the completion of park master plans at undeveloped county parks such as Polo Grounds, Aptos Village and Seacliff Village.

During March 2018, County Parks will present the Draft Strategic Plan at three community meetings to get input from you and other members of the public and on April 2, 2018, the Parks & Recreation Commission will hold a hearing to review and hear additional public comments about the Draft Strategic Plan. The final Draft Strategic Plan is expected to go before the Board of Supervisors in May.

Storm Drainage – A Brief Background

The County is in the advanced stages of a drainage plan for the Flats area and RDMIA has hosted presentations about the proposed plan. Rio del Mar experiences drainage and flooding issues and there is no question that the lack of adequate drainage infrastructure is an ongoing issue.

Zach Friend has spoken extensively with SC Public Works and county drainage experts about a solution to help fund a true drainage district in Rio del Mar (and in Seacliff which faces many significant drainage issues as well). A drainage district can provide the proper infrastructure to improve the 80 + year old drainage systems.

The flooding that occurs along Sumner Drive, Townsend Drive and areas along Spreckles Drive all tie back to the antiquated drainage approach that dos not convey water to proper channels. Many homes flooded push back the water off their properties into the street where it hopefully heads towards an old culvert. In many cases the water flows downhill flooding other properties.

Zach Friend will host a community meeting with RDMIA and the Seacliff Improvement Association to address long term drainage needs and solutions. County staff will be on hand to discuss drainage district details including boundaries, what the district currently funds, it's authority scope and what can be done to improve it.

District Drainage Information Meeting

Remember last winter? Does your street lack adequate storm drains? Did your property flood?

Supervisor Zach Friend is hosting a meeting to discuss drainage problems and solutions with county staff and residents. Issues addressed at the meeting will include:

- An understanding of the storm water management district's boundaries
- What the zone's authority is and what work can be done
- Funding challenges and options


